“See no evil” in Washington: Following the media coverage of the December 2nd San Bernardino terrorist attack, U.S. officials announced that the national alert system would be modified to warn the public of terrorism risks. Yet the public faces an even more terrifying threat from *homegrown* deception. With the 1989 easing of a “Soviet” threat, the Internationalist Establishment quickly seized on alternative threats to drive their planned totalitarian power grab. Specifically mentioned were *terrorism* and damage to the environment.

Our January *Action Report* examines three current issues — gun control, immigration, and climate change — to show how Americans were being seriously misled as we closed out 2015.

Our purpose is to help members provide leadership to their prospects. The difficult lesson we need to understand and get across is that, for freedom to survive, the root cause of our problems — a Conspiracy of deception and subversion — cannot be ignored.

Three Levels of Leadership

The ubiquitous first level of leadership is based on “public knowledge” driven by, or acceptable to, the Establishment. At this “safe” level, discussion centers on differences in judgment and ideological conviction. There is no suggestion of hidden totalitarian

intent. America’s challenge is viewed as merely winning an ideological debate and deciding which politicians offer the most compelling leadership.

“Leadership” confined to this first level serves as a *neutralizing* smokescreen, obscuring the real problem, which any *genuine* solution must address. The second level of leadership exposes the underlying causes — the subversive agendas and forces targeting our freedom — which are concealed by the media and ignored by politicians.

The third level consists of leadership for responsible, realistic solutions. Let us illustrate with examples.

Gun Violence or People Violence?

It is a moral outrage and a

national disgrace that civilians can legally purchase weapons designed specifically to kill people with brutal speed and efficiency.

Action Report quoted John Douglas, legendary FBI profiler and expert on the criminal personality. In his 1969 book, *Journey into Darkness*, Douglas concluded:

Unfortunately, no matter what we do with our criminal justice system, the only thing that is going to cut down appreciably on crimes of violence and depravity is to stop manufacturing as many criminals.... [T]he real struggle must be where it has always been: in the home.

Analysis at this “public knowledge” level can sometimes be useful, *but only if it feeds into leadership at the other two levels.*

Level II Analysis

At this level, we show that destructive public policy is not the result of stupidity or wrong thinking. Instead, we explain the extensive historical record of subversion of America’s institutions on behalf of totalitarian objectives, such as disarming the population.

Don Fotheringham’s *The President*

Makers tells much of this story with respect to the takeover of the media. It is vital to recognize that the Establishment has also worked to create and control media outlets that appeal to, and neutralize, conservatives.

The totalitarian agenda driving demands for gun control is widely ignored in those outlets. Yet *civilian disarmament* has been a revolutionary objective long before recent crimes of violence. As far back as 1958, in their classic “World Peace Through World Law,” published by Harvard University Press, Grenville Clark, the head of the United World Federalists, and Louis B. Sohn spelled out an agenda for a “world police force” and called for rigid controls on all firearms and ammunition possessed by police and private citizens.

Not surprisingly, the December 2nd San Bernardino terrorist attack quickly precipitated renewed calls for “gun control,” well before the facts were in. That same day, AFP reported: “The Democratic presidential hopeful Hillary Clinton tweeted: ‘I refuse to accept this as normal. We must take action to stop gun violence now.’”

Level III: Constructive Action

Of course, we dare not be satisfied with just helping others understand the problem. Our mission is to offer leadership for a responsible *solution* based on an understanding of America’s strengths and a realistic assessment of what we are up against. Freedom First Society sees that solution as organizing an army of patriots committed to providing *local* leadership at Levels II and III.

Immigration

The letter [from the U.S. Office of Refugee Resettlement] came after more than two dozen governors, mostly Republicans, vowed to block efforts to resettle Syrian refugees in their states following the Nov. 13 terrorist attacks in Paris. The governors said they fear that militants planning a terror attack could enter the country under the guise of seeking refuge from war-torn Syria....

The Obama administration counters that the vetting process is thorough and can take up to two years. President Barack Obama has said the U.S. will remain a welcoming place for refugees from around the world....

Roughly 2,200 Syrian refugees have been allowed in over the last four years. Obama has outlined a goal of bringing 10,000 more Syrian refugees to the U.S. during the current budget year.

Over the past couple of decades, much has been written about our immigration problem and policies. But most of that discussion remained at Level I, ignoring the real objectives behind the Establishment’s support for “open borders.”

Level II Answers “Why?”

As far back as 1983, President Reagan

stated: “This country has lost control of its own borders, and no country can sustain that kind of position.” Most Americans want to see our nation enforce its borders, but, despite overwhelming support for doing so, political action has been ineffective. **Why?**

Following the terrorist attacks of September 11, 2001, most Americans expected the federal government to tighten border security. But it did not happen. **Why?**

Answering those questions requires us to go to Level II and understand the conspiratorial objectives and Establishment drivers behind the “open borders” movement. That movement has thwarted the will of a naive public, while opening our doors to criminal elements, drug trafficking, and the terrorist threat.

But those destabilizing results are merely part of the Insider agenda for socializing the U.S. Another major Insider objective has been to use the voting power of immigrants from socialist countries to help solidify socialism in the United States. And to that end, Establishment foundations have supported revolutionary organizations that work to prevent immigrant populations from assimilating.

Level I Concerns

Even at Level I, there is plenty of reason for alarm. How effective has refugee screening been in the past? In 1999, Michael Levine, a highly decorated former undercover agent for the Drug Enforcement Administration (DEA), was interviewed regarding U.S. support for the Kosovo Liberation Army (KLA) (the Clinton administration would accept more than 20,000 Albanian refugees from Kosovo):

Backing the KLA is simply insane. My contacts within the DEA are quite frankly terrified, but there’s not much they can say without risking their jobs. These guys [the KLA] have a *network*

that’s active on the streets of this country. The Albanian mob is a scary operation. In fact, the Mafia relied on Albanian hitmen to carry out a lot of their contracts. They’re the worst elements of society that you can imagine, and now, according to my sources in drug enforcement, they’re politically protected.

It’s the same old story. Ten years ago we were arming and equipping the worst elements of the Mujahadeen in Afghanistan — drug traffickers, arms smugglers, anti-American terrorists. We later paid the price when the World Trade Center was bombed, and we learned that some of those responsible had been trained by us. [Emphasis added.]

Amazingly, following the Paris attacks, political discussion has focused on policies regarding *legal* entry into the United States, as though our porous borders no longer present a national security threat.

But we dare not keep our prospects at Level I, as does most conservative media commentary. There is no solution at that level — just frustration and false hopes that the right politicians will be elected to correct things.

“Climate Change”

Level I Criticism

Syndicated columnist and energy commentator, Llewelyn King, who accepts the Global Warming scare, nevertheless made some sense when he wrote:

If the Obama administration were as concerned with the reduction in greenhouse gasses, particularly carbon, as it says it is, it would not have given the back of its hand to nuclear power. Nuclear produces a lot of electricity and no greenhouse gasses. Zero....

Ironically, the 2015 UN Climate Change Conference was held in France, arguably the greatest success story in implementing this scorned American technology. In 2004, France’s 59 nuclear reactors produced 75 percent of that nation’s electricity!

But Level II Explains “Why”

Moreover, Milloy recognizes the true character of the movement — a Marxist power grab — and that, among its top leaders, pretended concern for the environment merely serves as an effective rallying cry. His book provides a good foundation from which to show the equally totalitarian agenda of those in the Establishment who have supported the movement.

Campaign for Decency — Curb the Courts

In the wake of the outrageous Supreme Court decision re same-sex marriage, we have an opportunity to build pressure on the legislative branch to use its authority to limit the Court’s appellate jurisdiction (Article III, Section 2).

Recommended action: Ask your congressmen to introduce a *concurrent* resolution similar to the model in our “Culture War” *Campaign Action Report* or to our online model resolution. **Send** us copies of any correspondence you receive in return. **See** our December *Action Report* for more details.
