**A “useful” enemy:** North Korea’s video purportedly showing a successful submarine missile test launch was later debunked. However, media coverage of the test totally ignored the ongoing Internationalist power grab such a threat served. Also ignored was Internationalist action to engineer the threat. In 1950, Insider General George C. Marshall prevented General Douglas MacArthur from destroying the Yalu River bridges allowing Red China to enter the war, rescue the North Korean invader, and kill Americans.

Last month’s *Action Report* examined several news stories to show the gap between “politically correct,” “see no hidden subversive agenda” news (level I leadership) and the reality of what is regularly concealed from the American people (level II leadership).

Our purpose was to help members sound a clear trumpet within their own sphere of influence as a foundation for level III leadership (responsible, realistic solutions based on a true level II understanding of our perilous situation).

Because the consequence of the

level I neutralizing news entertainment offered by the major Insider-owned “conservative” outlets is so deadly, we continue the comparison this month.

### North Korean Militarism

UNITED NATIONS (AP) — North Korea’s U.N. mission claimed Wednesday that its successful nuclear bomb test showed that it could now “wipe out” the United States, as the U.N. Security Council grappled with a response to the underground blast. — 1-13-16

The outside world has been paying close attention to the North’s efforts to acquire a submarine-launched ballistic

missile (SLBM) capability, which, if fully developed, would take its nuclear strike threat to a new level, allowing deployment far beyond the Korean peninsula and the potential to retaliate in the event of a nuclear attack.... AFP, 1-12-16

At level II (the *real* problem’s level), true leadership needs to explain that, as we showed in *Masters of Deception*, the Internationalists in

our own country were responsible for creating the Soviet and Red Chinese threats, through betrayal and building these nations up with American dollars. Maintaining North Korea as a continued enemy has served their interests as well.

North Korean militarism provides a welcome threat for the Internationalists to drive forward their plans for world government. Our Insider leaders were willing to have millions slaughtered and starved to build their international authority. We can expect no better treatment in this country.

### U.S. Soldier's Blood on Their Hands

From *Masters of Deception*: In testifying before the Senate Internal Security Subcommittee on April 9, 1952, former U.S. Ambassador Bullitt was asked by Senator Arthur Watkins if the Free Chinese had a navy. Bullitt replied:

Oh, yes. As a matter of fact, it has been quite an efficient force, although it is forbidden to act in any way by fiat of our government which has given orders to our fleet to prevent it from stopping the Communist supply ships going up to Korea. They sail right by Formosa [Taiwan], loaded with Soviet munitions put in the Polish Communist ships in Gdynia. They come all the way around and go right by Formosa and sail past there taking those munitions up, *taking those weapons up to be used to kill American soldiers in Korea*, and by order of our government the Chinese Navy is flatly forbidden to stop them on their way up there. [Emphasis added.]

### Short Memory re Iran

I've been fighting for twelve years with one thing in mind: We must stop Iran from getting a nuclear weapon.

Who in the “public” debate is reminding us that pressure from the Carter administration pushed the pro-Western Shah out of Iran, allowing a virulent anti-American religious fanatic, the Ayatollah Khomeini, to seize control? And, of course, no one dares point out that the same Internationalist influences still control U.S. foreign policy regardless of which party occupies the White House.

### “Gun Violence or People Violence?”

Obama, wiping away tears as he pleaded for citizens and lawmakers to be more resolute in tackling gun violence, announced measures to tighten federal background checks for gun

sales, require those in the business of selling guns to be licensed or face criminal prosecution, and *expand mental health treatment*. [Emphasis added.]

President Obama has ridiculed the notion that the government wants to eliminate private gun ownership. However, that is precisely the totalitarian goal of the Establishment foundations that dominate the executive branch. The problem with level I “politically correct” opposition is that the driving, subversive agendas and organizations are never exposed. And without that exposure, there can be no effective opposition.

Obama says his gun measures are justified if they can save just one life. Totally ignored is the enormous carnage that could very well result from civilian disarmament, as happened in Rwanda following UN-mandated disarmament.

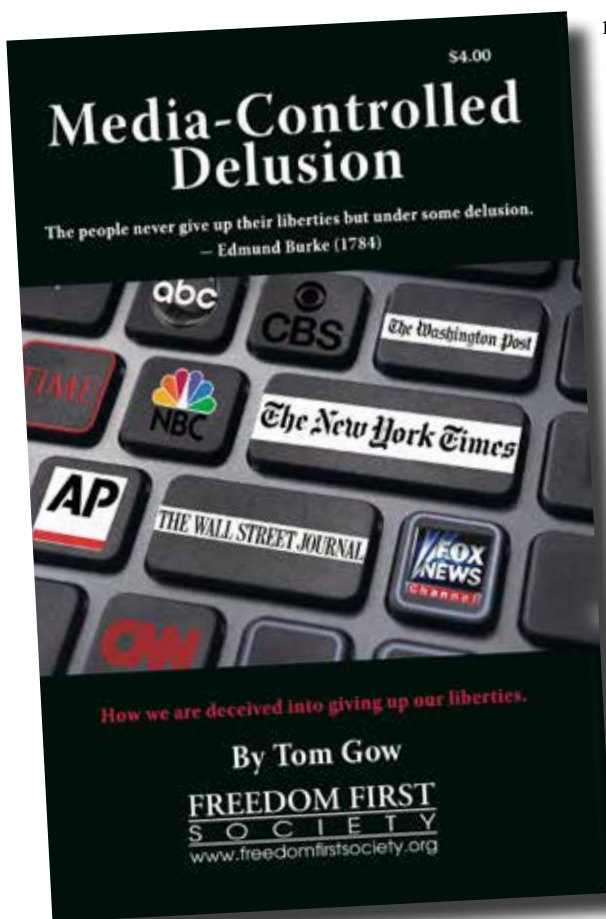

### Mental Health Treatment

In criticizing the President's plans to curb “gun violence,” GOP leaders ignored Obama's proposal for “a new \$500 million investment to increase access to mental health care.” However, House Speaker Paul Ryan seemed to be on board with this one:

“We have seen consistently that an underlying cause of these attacks has been mental illness, and we should look at ways to address this problem,” the Wisconsin Republican said, reiterating a frequently made GOP argument about overhauling the mental health system. — Roll Call, 1-4-16

Bush issued an executive order creating a new commission charged with finding ways to “improve America’s mental health service delivery system.” One year later, the Orwellian-sounding New Freedom Commission on Mental Health released its findings. Its final report recommended mental health screening for all Americans and, in a proposal that should alarm parents everywhere, recommended that the nation’s schools be used to assess the mental health of all schoolchildren.

Arguably the most serious delusion that threatens our liberty is the media-hyped professional-wrestling match between the Republican leadership in Congress, ostensibly fighting for smaller government, and liberal Democratic demands for more socialism and government control.

Above, Paul Ryan perpetuates the deception that the House must compromise with socialists, ignoring the proper use of its power of the purse. In promising “regular order” [sub-committee-passed individual appropriations bills] for next year, Ryan repeats the decades-old hollow promise that Congress will get tough *in the future*.

Even worse, both parties ignore the Constitution as the standard for fiscal restraint, while arguing merely over how much the nation can afford. With that approach, we no longer have limited government. ### Save the Constitution!

Our constitution was made only for a moral and religious people. It is wholly inadequate for the government of any other.

— President John Adams, 1798

Calls for a constitutional convention (a con-con) misdirect attention to a phony problem — the Constitution — while capitalizing on the illusion that a mechanical system alone can ensure good government. America’s problems are the result of decades of deliberate misinformation, the attack on religion, and the promotion of immorality. No mechanical adjustments through Article V can ensure freedom for a people either immoral or deluded.

After a temporary lull, the con-con battle heats up again. Only four states have no regular session this year: Montana, North Dakota, Nevada, and Texas.

Each of us needs to know who our state legislators are and how to contact them. The website for your state legislature can generally help you with those issues.

Let your legislators, and those in any committee considering a call, know how you feel about risking our Constitution to an ineffectual, dangerous Article V constitutional convention. Particularly, inform them that state legislatures cannot limit or restrict an Article V convention — much less call it back, once it has convened.

Twenty-four states have con-con calls currently under consideration. New measures may be introduced at any time. For the con-con calls that are live measures in your legislature, constantly check our website for the latest updates.

### Recommended actions:

- **Expose** your state legislators to the light and force of the truth about Article V con-cons. Introduce them to our “Dagger in the Heart” *Campaign Action Report*.

- **Involve** your prospects in our campaign by asking them to inform themselves and contact their state legislators.

## In Memoriam: G. Allen Bubolz

This past November 19, Freedom First Society Founding Member, G. Allen Bubolz of Appleton, Wisconsin died peacefully at age 79 after an extended illness with Parkinson’s disease. Allen graduated from Valparaiso College with a degree in electrical engineering and studied law at the University of Wisconsin. However, he served as a life insurance executive during much of his adult life, holding leadership positions with the SECURA insurance companies (he was president of Homeco Life).

Concerned about our nation’s future, Allen joined The John Birch Society. In 1986, Allen was invited to join the Society’s National Council and in 1988 was chosen as the Society’s Chief Executive Officer. In 1991, he stepped down from the CEO post, but remained as a member of the Society’s National Council.

In 2005, several JBS employees (including John F. McManus) deviously organized a selfishly motivated coup d’état, using the Society’s formal

Massachusetts legal structure to wrest working control from the Society’s Executive Committee. Allen Bubolz was one of the key figures to protest the betrayal and unconscionable disregard for the long-established procedures put in place by the Society’s founder, Robert Welch, for making JBS principal leadership changes.

In October 2007, when Freedom First Society was launched, Allen eagerly became a Founding Member.

Allen is survived by his wife Kay, seven children, and two brothers and a sister. His family, our organization, and our great country have lost a remarkable and dedicated patriot. Allen Bubolz will be sorely missed.
