### Importing Revolution

[T]ens of thousands of civilians have fled for their lives [to the Turkish border] though they still haven't been allowed to cross into safety. Turkey has absorbed more than 2 million Syrian refugees and now says it's reached its limit, leaving these exhausted people stranded.

— CBS Evening News, 2-8-16

Part of the Insider strategy for world control calls for destabilizing nation-states through massive immigration. With what's happening in Europe, it's more important than ever that the U.S. gain control of its borders and restrict legal immigration to what can reasonably be assimilated.

Unfortunately, there is no political

leadership exposing the subversive agenda behind the "open borders" movement. Indeed, the public needs a much better understanding of principle (**Level I**) and the subversive agenda behind the problem (**Level II**). So let's take a deeper look.

### America's Founding Principles

At the founding of our Republic, America's culture supported a nation of unprecedented opportunity and liberty. That culture was developed largely by fiercely independent European (Christian) immigrants and their offspring.

In his 1966 book, *The Hope of the World*, Dan Smoot, the former FBI agent and trailblazer in the freedom fight, explained the American ideal:

As I see it, the beginning of the

United States of America was the most dramatic and significant episode in a long pilgrimage — the pilgrimage of the Christian idea of law, liberty, and self-government. Christianity is the master principle of our organic documents of government — the Declaration of Independence, the Constitution and the Bill of Rights.

**Revolution by orchestrated immigration:** In February, CBS news reported on a new phase in the 5-year-old Syrian civil war. Supported by Russian airstrikes and its ally Iran on the ground, the Assad dictatorship mounted a brutal offensive against the rebel stronghold of Aleppo. Thousands of refugees fled to the Turkish border. But Turkey, having already absorbed more than 2 million refugees, closed its border. Nearby European nations with massive Islamic immigration suffer from the Insider-orchestrated turmoil of increasingly divided cultures.



Those who expressed a view wanted to limit incoming flow primarily to individuals who already possessed substantially our culture, would readily assimilate, and were likely to develop exclusive loyalty to their adopted country.

John Jay, our nation's first Chief Justice, wrote in *Federalist No. 2*:

Providence has been pleased to give this one connected country to one united people — a people descended from the same ancestors, speaking the same language, professing the same religion, attached to the same principles of government, very similar in their manners and customs, and who, by their joint counsels, arms, and efforts, fighting side by side throughout a long and bloody war, have nobly established their general liberty and independence.

In a November 15, 1794 letter to Vice President John Adams, President George Washington, argued against a proposal to transplant a university to the U.S., accompanied by a sizeable *body* of foreigners, “for, by so doing, they retain the language, habits and principles (good or bad) which they bring with them.”

In his 1790 report on immigration to the 1st Congress, James Madison argued that America should “welcome every person of good fame [who] really means to incorporate himself into our society, but repel all who will not be a real addition to the wealth and strength of the United States.”

Alexander Hamilton supported an immigration policy that would “render the people of this country as homogeneous as possible,” a policy he said that “must tend as much as any other circumstance to the permanency of their union and prosperity.” In 1802, he warned of the dangers of massive immigration by peoples still devoted to their former homelands:

The safety of a republic depends essentially on the energy of a common national sentiment; on a uniformity of principles and habits; on the exemption of the citizens from foreign bias, and prejudice; and on that love of country which will almost invariably be found to be closely connected with birth, education, and family....

The influx of foreigners must, therefore, tend to produce a heterogeneous compound; to change and corrupt the national spirit; to complicate and confound public opinion; to introduce foreign propensities.

### **Subversive Design (Level II)**

America's unique culture has long been under attack. While the results of this attack are apparent, its origins and ultimate objectives remain hidden from the general public.

In his *Prison Notebooks*, Italian communist theorist Antonio Gramsci (1891-1937) argued that to build a socialist world, revolutionaries first needed, in essence, to capture the culture. By the end of World War II, the liberal-Left had managed to capture the arts, music, motion pictures, education, and the media.

Quietly driving this takeover was immense wealth. In 1953, a special House committee chaired by Representative B. Carroll Reece of Tennessee began investigating America's tax-exempt foundations and the revolutionary causes they supported. With respect to education, for example, the committee reported:

The impact of foundation money upon education has been very heavy, largely tending to promote uniformity in approach and method, tending to induce the educator to become an agent for social change and a protagonist for the development of our society in the direction of some form of collectivism.

### **Revolution thru Immigration**

What better way to alter the character of a nation than to import foreigners in such numbers that they don't assimilate? And particularly to bring in those whose traditions are rooted in centuries of paternalistic and tyrannical rule?

The Insiders have promoted this method of revolution in two complementing ways: first, by instigating, directly or indirectly, pressure for migration (e.g., civil war in Syria, socialism throughout Latin America and the world, and support for the state sponsors of terrorism, revolution, and the international drug trade). (For documentation, see *Masters of Deception* and *Organize for Victory!*)

The other complementing strategy has been to fuel the “open borders” movement. The Ford Foundation


has financed organizations that have frustrated border enforcement, pushed for liberalized immigration policies, and worked to prevent assimilation. In his 1994 exposé, *Importing Revolution: Open Borders and the Radical Agenda*, William R. Hawkins tabulated the published contributions of the Ford Foundation to radical pro-immigration organizations. Just to MALDEF (the Mexican American Legal Defense and Education Fund), he reports contributions totaling over \$18 million between 1968 and 1992.

Blaming immigrants, legal or illegal, for negative impacts is to focus on the result while ignoring the cause.

**Recommended action:** Specifically, the solution is to **expose** the Internationalist Conspiracy. Widespread exposure will hinder its promotion of socialism, tyrannical regimes, and regimes fostering terrorism and allow free institutions to emerge throughout the world. Ultimately, such exposure requires **building Freedom First Society**.

### Register Women for the Draft?

Gen. Mark Milley, the Army

chief of staff, and Gen. Robert Neller, commandant of the Marine Corps, both testified this month that because all combat roles are now open to women, women should register for the Selective Service as all American men must do when they turn 18. — *Stars and Stripes*, 2-14-16

Marco Rubio, Jeb Bush and Chris Christie all said or suggested they'd support women being required to enroll in Selective Service and be eligible for the draft, since female service members can now serve in combat roles. — CNN.com, 2-8-16

Although reinstating the draft is not *currently* on the table, the purpose of Selective Service registration is to support a draft. In the above *Stars and Stripes* op-ed, veteran editorial writer Ben Boychuk makes an excellent **Level I** point:

Extending the draft to women isn't about fairness or equality. It's madness born of forgetfulness. We're forgetting what it means to be men and women. We're forgetting why our daughters and sisters should be protected, not made into cannon fodder. We're forgetting what it means to be a civilization worth defending in the first place.

But we need to go to **Level II**. This assault on women in the name of equality is not simply a matter of "madness born of forgetfulness" — it's part and parcel of the culture war designed to undermine the foundations of our resistance to totalitarian control.

### Presidential Politics Swindle

It's not surprising to see presidential *candidates* support "political correctness" — even candidates seeking to woo conservative voters.

But even worse, the administrations

of those presidents touted by the media as the most conservative have labored to implement the Insider agenda, contrary to their public image. In 1987, Brigadier General Andrew J. Gatsis, U.S. Army (Ret.), one of America's most decorated soldiers, authored an in-depth analysis of "Women at War" and the forces propelling such an objective:

The pace of sex integration accelerated during the Carter years.... Mr. Carter and many of our senators said women would not be put in combat if drafted; yet, on November 16, 1979, I testified in Congress before the House Armed Services Subcommittee for Military Personnel against President Carter's proposal to do just that through a Department of Defense proposal....

Nothing really changed with the incoming new administration. His anti-ERA rhetoric notwithstanding, President Reagan has promoted the goals of this amendment and supported it indirectly by such actions as his nomination of ERA supporter Sandra O'Connor as Supreme Court Justice. As a member of the government-sponsored civilian feminist organization, Defense Advisory Commission on Women in the Service (DACOWITS), Judge O'Connor initiated and was the principal sponsor of the effort to repeal the laws that exempt women from military combat. DACOWITS is a group of 31 civilian feminists appointed by the Secretary of Defense to advise him on how to use women in the military. They work quietly behind the scenes, pushing for direct combat roles for women....

The former Assistant Secretary of Defense for Equal Opportunity, Kathleen Carpenter, one of the most avid women liberationists in the Carter-controlled Pentagon, was replaced in the Reagan



Administration by Dr. Sharon Lord. Lord, a strong feminist and former president of NOW in Tennessee, continued to advance Carpenter's policies and, after only three months in office, recommended that women be placed in direct combat roles....


Don't be deceived: The registration of women is always just around the corner.

## Save our Constitution!

On February 19 we emailed members an "Urgent Action Request" that reported the following:

Two states (Tennessee and Florida) have already passed Con-con resolutions this year, and resolutions have passed single chambers in other states.

The speed with which several measures have traveled through state legislatures is alarming. We saw nothing like this last year.

The well funded Con-con proponents seem to have adopted a strategy of devoting extensive preparation to specific measures planned (or already introduced) in selected states. They then "pre-set the dials" on these measures, so that when unleashed they will move with terrific speed — leaving opponents wondering what hit them.

**Recommended action:** The best way to combat these "lightning fast" surprise attacks is to build sufficient understanding and informed pressure *prior* to the attacks.

## Campaign for Decency: Curb the Courts

The death of a great Supreme Court Justice, Antonin Scalia, leaves a gap in the judicial wisdom remnant on the high court. It brings home to us the danger of depending on — or trusting in — "the right stuff" populating the federal bench.

But did our founders expect us to do either? Definitely not: If judicial wisdom takes leave, Article III, Section 2 gives Congress power (and responsibility!) to constrain the judicial branch.

But Congress will do so only when pressured by an informed electorate. And right now, all too few know about

this constitutional provision. We must change that!

**Recommended action:** Our website provides rare, sound educational material for enlightening friends and neighbors about the constitutional power Congress has over the judicial branch. **Ask them** if they know about it. Also, **ask your representatives and senators** if THEY know about it! And **send them a link to**, or copy of, our model resolution (limiting the Supreme Court's appellate jurisdiction), **asking them to cosponsor and even introduce such a resolution.**
