Dos Amigos: President George W. Bush's 2003 "guest-worker" proposal was blatant amnesty.

As we write, Congress is in the process of addressing the issues of DACA

recipients, border enforcement, and changes to immigration law. The current demand for amnesty highlights the plight of those who were brought here illegally as children and have grown up in this country.

As of January 2017, 740,000 had applied for President Obama's DACA program granting a two-year renewable period of exemption from deportation. Since not all those eligible had applied for the exemption, President Trump is estimating the total at 1.8 million.

But whose fault is it that there are 1.8 million early childhood arrivals illegally in the United States? Amnesty proponents duck that question. Of course, the fault is with the Federal government for refusing to do its job and enforce our Southern border.

Broken Promises

Given the history of immigration betrayal, we need to understand the broken promises and deceptions of the past, so we can provide essential leadership to our friends and neighbors.

As far back as the mid-sixties, Establishment Insiders were seeking to open up our borders and change the cultural makeup of the United States. Their standard pincers strategy was implemented with pressure from above

and pressure from Establishmentfunded radicals below.

That agenda led to the 1965 Immigration and Nationality Act, which established a radical new national-origins immigration policy. At the same time, our nation would suffer from a growing rise in illegal entry along our Southern border and subsequent pressure to legalize the status of the intruders.

1986 IRCA

The Immigration Reform and Control Act (IRCA) of 1986, signed into law by *Republican* President Ronald Reagan, provided the original amnesty for illegal immigrants. IRCA incorporated the recommendations of a commission created by President Jimmy Carter and headed by Reverend Theodore Hesburgh (Council on Foreign Relations member and fellow Trilateralist).

The current Leftist Senate minority leader, Charles Schumer, was a representative at the time and very much involved with the IRCA legislation. Schumer authored the Special Agricultural Workers (SAW) amnesty provision.

The IRCA amnesties went into effect, but the promised border enforcement proved ineffective (e.g., substantial increases in the border patrol were delayed ten years). In fact

the INS budget became so strained with processing some three million applicants for legal residence status at 107 "legalization centers" that INS attention to border enforcement was weakened. (Approved applicants were eligible for citizenship in five years.)

By Any Other Name

Not surprisingly, the 1986 "Reagan" amnesty inspired further violation of our borders in expectation of future amnesties. As a result, amnesty became very unpopular with many Americans.

So amnesty proponents would use several euphemisms for their proposals, such as "regularization," "legalization," "permanent status," and "earned adjustment." The criminals who broke our laws would become "undocumented workers." And the term "migration" would often replace "immigration," subtly supporting the Internationalist agenda of eliminating national borders altogether.

Two years after the 9/11 attacks, *Republican* President George W. Bush took the lead on another amnesty proposal. But he carefully cast his proposal as "immigration reform" and denied that he was proposing amnesty.

At a January 12, 2004 news conference in Monterrey, Mexico, President Bush, standing alongside Mexican President Vicente Fox, touted his plan:

This plan is not amnesty, placing undocumented workers on the automatic path of citizenship. I oppose amnesty because it encourages the violation of our laws and perpetuates illegal immigration. [Emphasis added.]

Representative Ron Paul (R-Texas) did not buy Mr. Bush's amnesty subterfuge:

Millions of people who broke the law by entering, staying, and working in our country will not be punished, but rather rewarded with a visa. This is amnesty, plain and simple. Lawbreakers are given legal status, while those seeking to immigrate legally face years of paperwork and long waits for a visa.

Mr. Bush also argued that "our current limits on legal immigration are too low" and he proposed to work with Congress to "increase the annual number of green cards that can lead to citizenship" for illegal aliens already in our country. Following Mr. Bush's announcement, there was an immediate increase in illegal border crossings.

McCain/Kennedy Bill

In 2005, key elements of President Bush's "immigration reform" proposal were introduced as the "Secure America and Orderly Immigration Act." Its chief sponsors in the Senate were Senators John McCain (R-Ariz.) and Ted Kennedy (D-Mass.).

The McCain/Kennedy bill had support from Insider-supported "immigrants' rights" groups. The Center for Community Change (CCC) would praise the McCain Kennedy Bill for creating "a path to citizenship for millions of undocumented workers." The Center for Community Change was created in 1968 by disciples of

Marxist Saul Alinsky and funded by the Ford Foundation.


The McCain/Kennedy bill also sought to advance another Insider objective. Title I called for "development of multilateral partnerships to establish a North American security perimeter and improve border security south of Mexico." This concept of a continental security-perimeter first appeared in the Jan./Feb. 2004 issue of Foreign Affairs, the Council on Foreign Relations journal. Subsequently a CFR task force presented the plan to a subcommittee of the Senate Foreign Relations Committee.

In the following years, other measures proposing new amnesties were introduced in Congress, but since the 1986 IRCA none have yet made it into law.

Combo-Con

One of the greatest deceptions in immigration legislation has been the promise to combine amnesty with getting tough on border enforcement from this point forward. With IRCA, the amnesty happened, but effective border enforcement did not.

In light of this history, the ongoing terrorist threat, and the high-level

support for the open-borders agenda, the public should demand that Washington first do its job of enforcing our borders: When your tub overflows, you turn off the spigot first and then worry about mopping up. Unless government seriously addresses its enforcement failure, there will just be calls for further amnesties down the road.

But of course, to account for our chronic enforcement failure, one must recognize what's driving the open-borders movement.

Steps to a Solution

Realistically, sensible proposals to enforce our border and reform our immigration laws cannot succeed at this time. Though it may be hard for some to swallow, massive uncontrolled immigration is sought by the Insider Establishment and has been supported by Republican Presidents, including Ronald Reagan and George W. Bush.

Moreover, that Establishment eagerly engages in deception to hide its plans and goals from Americans and to sell its unpopular amnesties, often under other names. We need to help our friends and neighbors understand that merely electing more Republicans is not the solution. While many of the Democrats are obvious wolves, the big-government Republican wolves-in-sheep's-clothing are even more dangerous.

The forces controlling the politics in Congress must first be exposed. It's simply unrealistic to expect that "negotiations" within the current Congress can accomplish anything constructive. It would be like expecting to negotiate with Al Capone the repeal of prohibition.

But the current losing political battle creates an opportunity to help build a better Congress by informing others and letting our congressmen know that an increasing number of their constituents won't accept betrayal.

The initial step must be to create recognition among a wider audience of why immigration is out of control and why Washington currently will

frustrate any real solution. That requires exposing conspiratorial influence, objectives, and actions and highlighting the refusal of politicians and the controlled media to expose the subversion.

And finally, it means finding those who will get out of their chairs when they recognize the need and help us "Grow to Win!"

Congress: Just Vote the Constitution!

The February passage of the Bipartisan Budget Act of 2018 highlights the corruption of the current Congress. Rep. Mo Brooks (R-Ala.) blasted the massive spending spree as a "debt junkie's dream."

The Act was negotiated under the leadership of Chuck Schumer and Mitch McConnell with input from House Minority Leader Nancy Pelosi and Speaker of the House Paul Ryan.

Up to February 8, the Republican leadership had used four short-term continuing resolutions to keep the federal government funded during FY 2018. Most were passed on the shoulders of GOP support, while offering concessions to attract enough Democratic support to offset GOP defections. Nevertheless, the media and the Democrats kept insisting that eventually the GOP would have to sit down with the Democrats and work out a bipartisan compromise, i.e., accede to key Democrat demands, in order to pass appropriations.

We don't accept that claim. A constitutionalist House could force Senate acceptance by using its power of the purse strategically through regular order (i.e, no omnibus spending bills). But the current GOP House leadership has no intention of rolling back unconstitutional government and would rather work out a deal with socialist Democrats than with conservatives in its own party.

The good news is that 16 GOP senators refused to go along with the betrayal compared to 34 who voted for the deal. In the House, 67 voted no

compared to 167 ayes. 73 Democrats voted aye to give the measure a majority. Please see our description of the deal on our FFS scorecard and share it with others.

Another CFR Appointment

In November, Pres. Trump nominated Jerome H. Powell to replace Janet Yellen as Chair of the Federal Reserve. At the time of his nomination, Jerome Powell had been a member of the Council on Foreign Relations since 1995. The Senate approved the nomination on January 23rd by a vote of 84 to 12. The 12 voting to reject the nomination included just three GOP senators: Ted Cruz (Texas), Mike Lee (Utah), and Rand Paul (Kentucky).
