The “Deep State” scam: To mislead and confuse the public, the Insiders of the Conspiracy have allowed, and even encouraged, the concept of a “Deep State” conspiracy to become popular. But the ruthless Conspiracy for totalitarian power is far more than a group of unelected swamp creatures seeking to protect their turf against an ostensibly “outsider” president. A surprising variety of sources supports the scam, including Fox News’s Sean Hannity, *The New American* magazine, Ron Paul’s Campaign for Liberty, and, of course, Alex Jones.

The “Deep State” Deception

As part of their strategy for world domination, the Insiders of the Conspiracy have long sought to neutralize resistance while disparaging conspiracy “theory” as a resort of the ignorant. Now, however, the Insiders have allowed, and even encouraged, the concept of a “Deep State” conspiracy to become popular. But this popular view of unelected bureaucrats conspiring to protect their turf against “an outsider” president actually serves to obscure the real threat.

Counterfeit Leadership

At one time, The John Birch Society was the most reliable source for responsible leadership in exposing the Conspiracy. That mission has obviously changed.

Now the JBS seeks to identify its Conspiracy message with the “Deep State” publicity of Fox News (created by Rupert Murdoch, Council on Foreign Relations [CFR]) and the mainstream media, and to promote the Establishment-supported image of President Trump as *an outsider* threatening the Establishment.

In doing so, the JBS forfeits the leadership upon which so many have depended to expose a very serious threat. JBS Founder Robert Welch described the Conspiracy as the “most ruthless conspiracy in human history” — a far cry from a group of swamp creatures protecting their turf.

Even worse, the JBS and its publication, *The New American*, are now reinforcing the Establishment campaign to neutralize conservatives.

It’s certainly worth asking why? To establish what we are talking about, let’s look at some examples.

Twice so far this year, *The New American* has devoted an entire issue to reporting on the “Deep State.” We’ll look at the first, the January 8 issue.

In the opening article, “Deep State: Pulling Strings from Behind the Scenes,” we read:

Whatever one may think about

Trump and his policies, there is a great deal of evidence suggesting that the 45th president is under attack by the Deep State as well. Longtime establishment loyalist Newt Gingrich hinted at it on Fox News before the election. Commenting on why Trump had the establishment in a panic, Gingrich said he is “an outsider; he’s not part of the club; he’s uncontrollable; he hasn’t been through the initiation rites; he didn’t belong to the secret society.” [Emphasis added.]

The New American avoids drawing the obvious conclusion. If Trump were “uncontrollable” and “not part of the club” and “under attack by the Deep State,” then why would “longtime establishment loyalist Newt Gingrich” have stumped for Trump and Trump’s agenda? (See Gingrich’s 2017 book “Understanding Trump” promoted by Trump apologist Sean Hannity.)

And why would President Trump appoint members of the Establishment’s Council on Foreign Relations (CFR) to high positions, such as his appointment of CFR veteran John Bolton as his National Security Advisor? (See our post, “The John Bolton Charade.”) Something is very fishy! The Establishment wants us to think that President Trump is not its friend, and *The New American* reinforces that objective.

We are reminded that Jimmy Carter also campaigned as *an outsider* to gain the presidency. Later, it was revealed that Insider Zbigniew Brzezinski had groomed Carter to be president, after Carter had become a founding member of David Rockefeller’s Trilateral Commission.

The next article, “Bureaucracy vs. Trump, America, Constitution,” reinforces the false leadership. We are given a very watered-down concept of conspiracy as a bunch of unelected bureaucrats worried about protecting their turf from a president who had

briefly promised to drain the swamp. In fact, after the election, President Trump disavowed the concept, according to his Establishment-supporter Newt Gingrich.

Indeed, the article excuses Trump’s failure to drain the swamp as “getting bad advice,” while trivializing the real Insiders in the President’s circle:

He may very well be getting bad advice from “Deep State” operatives....

In fact, some of the Deep State’s leading luminaries — such as fanatical “New World Order” advocate and population-control zealot Henry Kissinger ... has even been embraced by Trump in recent months. On October 10, Kissinger visited the Oval Office and was showered with praise by the president. “Henry Kissinger has been a friend of mine. I’ve liked him, I’ve respected him,” Trump said of the man who practically embodies the Deep State swamp. “He’s a man I have great, great respect for.”

Consider: Donald Trump has criticized NAFTA as *a bad deal* for America and is seeking to renegotiate *its terms*. But NAFTA is designed as a steppingstone to regional government à la the European Union. As such,

it constitutes a very serious threat, ignored by the President. The U.S. needs to get out of NAFTA, not renegotiate it. Yet President Trump’s “friend” Henry Kissinger and David Rockefeller were the primary champions of NAFTA.

In short, the American people are being scammed by the idea of a Deep State. Donald Trump is no serious threat to the globalist agenda, and *The New American’s* focus on the popularized “Deep State” bureaucracy of self-serving bureaucrats obscures the real looming danger.

Elsewhere, the magazine speaks of a “Deep State behind the Deep State” and ties the concept to the Council on Foreign Relations, the Trilateral Commission, and the Bilderberg network, as well as the secret societies.” But that only compounds the damaging confusion. (For more examples, please see our expanded article of the same name on our website.)

The Bottom Line

The attacks on President Trump from the Left have the effect of driving many conservatives more firmly into the pro-Trump camp. Reports of a Deep State conspiracy opposed to President Trump have the same effect.

Although the motivations of the several sources may be different, they

all distract responsible Americans from the solid evidence of a Conspiracy to build a totalitarian world order. And they help many Americans decide to sit back and watch the President fight their battles.

Even those who believe that President Trump has good intentions should recognize that a President doesn't have the power to reverse course alone. Our Founding Fathers and the Constitution created the House of Representatives as the means to control and rein in our government. Yet Trump's message seems to be "leave it up to me – I'll do it for you." Yet this should alarm his followers, as Trump won't be president forever.

We also observe that Trump doesn't promote the principles of freedom, such as the Constitution, so he is promoting no real agenda to undo the inroads of the Conspiracy and he is providing no useful legacy to the next administration.

This is no time to sit back and expect any president to solve our problems. The Conspiracy's agenda is moving rapidly forward and can only be stopped when more and more Americans inform themselves (not with Fox News) and become involved.

There are plenty of reasons to be

concerned. For example, there is the collusion in Congress to ignore the Constitution and our national debt, resulting in the decline in middle class opportunity. There is the widespread extolling of "diversity" as a replacement for a culture that supports freedom. There is the attack on the traditional family. And there is the drive to legitimize the pot culture, as though the human race was created to fill an opium den.

The China Threat

China's military has expanded its bomber operations in recent years while "likely training for strikes" against the United States and its allies, a Pentagon report released on Thursday said.

If that is so, informed Americans should be asking why those Internationalists responsible for building China into a serious threat are not being put on trial.

The history of Insider support for the build-up of China at the expense of the U.S. goes back decades. It includes President Reagan's determination that the Export-Import bank should help the People's Republic purchase

steel-making equipment. President Clinton's transfers so violated national security that it became the basis for the Chinagate scandal.

And another key player in the build-up was President Trump's "friend" Henry Kissinger (and his Kissinger and Associates).

Such an investigation and trial will not happen any time soon, given the influence of the Insiders involved and the agenda of the Conspiracy. That agenda requires crises, real or imagined.

Congress: Just Vote the Constitution!

September 30th marks the end of the federal government's Fiscal Year 2018 and the expiration of that year's appropriations. As we go to press, it looks like the House and Senate will agree on several of the FY 2019 appropriations bills in "minibus" groups, funding the greatest portion of the government for the new fiscal year.

Congressional leaders and the Trump administration have agreed to delay the Dept. of Homeland Security appropriations bill, which would include the president's request for border wall funding, until after the November election. All areas of the government not included in approved appropriations bills will be funded through December 7th, by continuing resolution.

We are scoring the appropriations bills coming out of House-Senate

conference committees. An example is the “Energy and Water” minibus (see House Roll Call 399, 9-13-18). The committee legislation has compromised to the Left to make sure that the Democrats come on board. So the Republican passed bills that were bad before are even worse now.

If the federal monster is to be restrained and put on a firm diet, it is essential that opinion molders be informed of the reality of what Congress is doing. That’s why we urge members to keep directing others to our online Scorecard.

Save Our Constitution!

This month we continue, with our third installment, a series on major

groups pushing an Article V Con-con.

A group that has helped increase support for a Con-con — but claims not to be about a Con-con — is the Regulation Freedom Amendment Campaign (www.noregulationwithoutrepresentation.com). Wanting to “End Regulation Without Representation,” the group seeks to persuade Congress to propose the “Regulation Freedom Amendment”:

Whenever one quarter of the Members of the U.S. House or the U.S. Senate transmit to the President their written declaration of opposition to a proposed federal regulation, it shall require a majority vote of the House and Senate to adopt that regulation.

The campaign has two websites, a Facebook page, and a National Chairwoman, Tomi Collins. One of those websites purports to belong to “The Madison Coalition” (www.regulationfreedom.us).

Although the group claims to want to “to force Congress to propose the Regulation Freedom Amendment ... without a Convention,” the two steps

they propose to achieve that would do so by presenting a credible, imminent threat of a Con-con: 1) get 2/3 of the states to pass resolutions urging Congress to propose the Regulation Freedom Amendment (they claim to have passed this resolution in “19 state legislative chambers”); and 2) get either a) “Faithful Delegate” laws enacted in a majority of states, or b) a “10th Amendment Rule” adopted in the U.S. House, or c) a “10th Amendment pledge” taken by 51 Senators.

Congress would then interpret this combination as saying, “Propose this amendment, or we’ll force a Con-con.” So, this group is either openly bluffing — since, according to them, they don’t really want a Con-con — or, are quite willing to use their threat (contrary to their claims).

Recommended action: With the 2018 legislative sessions wound down for the most part, this is still a good time to approach friends and neighbors and make them aware of the dangers of an Article V Con-con.
