## Effective Action

To sit at home, read one’s favorite paper, and scoff at the misdeeds of the men who do things is easy, but it is markedly ineffective. It is what evil men count upon the good men’s doing.

— Theodore Roosevelt, 1895

Today, we might restate Teddy’s admonition as: “To sit at home, watch Fox News, and scoff at the misdeeds of men who do things is easy, but it is markedly ineffective.” So what is effective?

Effective action starts with a correct diagnosis of the disease — today, a well entrenched Conspiracy to enslave mankind. Above all, that Conspiracy

practices deception to prevent effective resistance. (The superficial and misleading entertainment of Rupert Murdoch’s Fox News certainly serves that purpose.)

The corresponding solution is to expose the deceptions, goals, and subversive influences of that Conspiracy. And that requires bottom-up *organization* of a segment of the intended victims — under sound leadership.

Our challenge is to convince uninformed *or* *misinformed* conservatives of the necessity of *organizing* a principled counterattack (see “Grow to Win!” below).

## Hiding Revolutionary Organization

One step in waking up conservatives it to show them that we face highly

*organized* enemies, aided and *concealed* by the Establishment media, including Fox News, and therefore we, too, must organize.

Two degrees of concealment are common. Often reports of protests mention no organization at all, giving the impression that Americans just like us are voicing their sincere grievances. But when organizations, such as “Black Lives Matter,” are mentioned, we are expected to assume that the organization exists

merely to promote its advertised purpose. The reports provide no hint of a larger revolutionary objective — unaccountable power.

In general, the news highlights Left-wing *front* organizations, which draw their inspiration and energy from revolutionary organization. That underlying organization is always concealed, as is its common financial support from the Establishment it serves.

## Pueblo Sin Fronteras

Examples of such concealment are everywhere. Consider “Pueblo Sin Fronteras,” a front organization supporting the migrant caravan assault on our Southern border. On December 23, AP reported:

Thousands [of Central Americans] are now in Tijuana on the U.S. border, where they are likely to be camped for months or longer with no easy way to get into the United States, creating what is fast becoming a humanitarian crisis in this overwhelmed city.

Many blame Pueblo Sin Fronteras, or People Without Borders, made up of about 40 U.S. and Mexican activists.

Critics, including former allies and some of the migrants themselves, say Pueblo Sin Fronteras downplayed the dangers of such treks.... [Emphasis added.]

Two weeks later, Reuters (1-4-19) reported that Central American migrants were protesting a government closure of a Tijuana shelter:

Tijuana officials cited sanitary reasons for closing the shelter...

Officials told migrants that they could move to the bigger shelter, run by the federal government, about 7 miles (11 km) from the border....

By mid-afternoon, several

dozen migrants had refused to leave and were *joined by U.S. activists*, as federal and local police in riot gear took formation at the entrance. [Emphasis added.]

“U.S. activists”? How were these activists recruited, organized and supported, and for what purpose? Let’s look at a common pattern.

## Developing Revolutionary Activists

The Left has long recognized that college campuses provide its best source of recruits. Leftist professors and student organizers appeal to the idealism of youth and, through a variety of campaigns, develop hardened activists. During the 1960s, Students for a Democratic Society (SDS) was a prominent student front group (receiving substantial Establishment funding). SDS activist James Kunen reported Insider influence at the 1968 SDS convention:

[Men from Business International Round Tables] offered to finance our demonstrations [at the Democratic National Convention] in Chicago. We were also offered ESSO (Rockefeller) money. They want us to make a lot of radical commotion so they can look more in the center as they move to the left.

— James Kunen, *The Strawberry Statement: Notes of a College Revolutionary*, New York: Random House, 1969, p. 112

New York Representative Alexandria Ocasio-Cortez (see our *January and December Action Reports*) supports the modern organized effort to allow politicians to “look more in the center as they move to the left.”

Ocasio-Cortez is a member of the Democratic Socialists of America. She worked as an organizer for the 2016 presidential campaign of fellow Democratic Socialist and U.S. Senator Bernie Sanders.

At age 16, while at Yorktown High School, Ocasio-Cortez joined the National Hispanic Institute, now the largest Latino youth organization in the United States. In 2011, she graduated from Boston University with a degree in international relations and economics. Along the way, she developed her commitment to the socialist agenda and earned the confidence of revolutionary organizations such as MoveOn.org and Black Lives Matter, which endorsed her candidacy.

Since her recent election to Congress as its youngest woman member ever, Ocasio-Cortez has received massive positive attention from the Establishment media. The attention

provides her a forum to promote the revolutionary agenda, such as a “Green New Deal,” “Medicare for All,” and abolition of the US Immigration and Customs Enforcement agency (ICE).

The Democracy Summer Leadership Pac, founded last year by “progressive” Representative Jamie Raskin, provides a current example of the Left using the schools as a source of recruits. The Pac’s website boasts:

Democracy Summer is a one-of-a-kind political Democratic Fellowship that teaches high school and college students the nuts-and-bolts of political organizing, the arts of electoral mobilization, the critical issues of the day, and the history of *progressive political change*. Our mission in 2018 is to deploy Democracy Summer Fellows to help Democratic candidates win key elections in swing districts across the country and elect a true-blue Democratic Congress in 2018....

Dozens of Democracy Summer Fellows, joined by Raskin’s veteran campaign volunteers, have been working these past weeks throughout Virginia, Pennsylvania, Iowa and Maryland

to help flip swing districts from Red to Blue and *build support for strong progressive politics* for the long haul. [Emphasis added.]

Raskin Fellows were notably active in Pennsylvania in support of Rep. Mary Gay Scanlon’s successful campaign for Congress. Scanlon, identifying herself as a “progressive,” supports greater gun control, decriminalization of marijuana, “Medicare for All,” expanded protection of LGBTQ rights, and same-sex marriage — a whole range of revolutionary vehicles for further empowering government and reducing resistance from a middle class.

And with the increasing takeover of college education policy by the federal government, the Establishment’s radical agenda, such as promoting “cultural diversity,” quickly permeates both.

Revolutionary movements are necessarily organized. However, they have never been successful without sufficient financial support that “allowed” them to succeed. 20th Century historian Oswald Spengler had it figured out when he wrote in his classic *Decline of the West*:

There is no proletarian, not even a Communist, movement, that has not operated in the interest of money, in the directions indicated by money, and for the time permitted by money — and that, without the idealist amongst its leaders having the slightest suspicion of the fact.

Tough, but essential lessons!

### Grow to Win!

Practically everything we have ever published, sponsored, or produced has been in great part for the purpose of assisting our members in this process of member-to-prospect contact, cultivation, and development.

Mr. Welch’s right hand for more than two decades, both recognized that building an organization was the key to exposing and defeating the Conspiracy. And they understood that sufficient recruiting would depend on the initiative of its organized members.

Successful recruiting requires work and *persistence*. The work involves asking questions of prospects, listening to their concerns, and directing them to sound information and solutions. Ultimately, prospects decide themselves whether they are persuaded by, and interested in, what we have to offer.

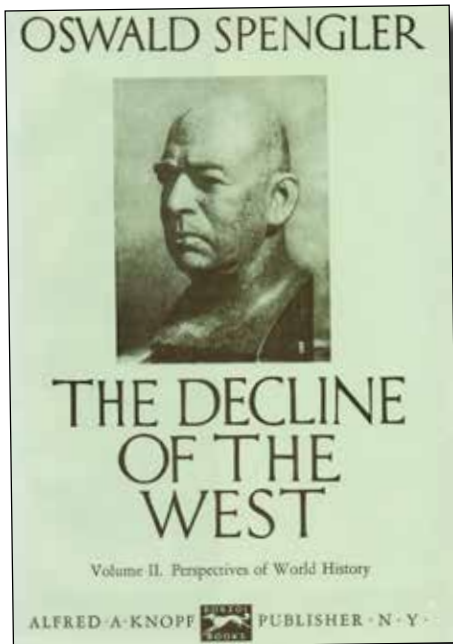
One means to develop that interest is to share our post alerts. Think of whom you know who would be interested in a particular alert topic. Another recent outreach tool is our scorecard trifold.

Whichever outreach tool you use, be sure to follow up to compete for the prospect’s attention and create that spark of interest in joining Freedom First Society. Ask for a reaction and tailor your follow-up to the prospect’s interests and concerns.

One step is to suggest that the prospect sign up for our alerts. And, of course, when you uncover serious interest, we recommend inviting the prospect to a presentation of the Freedom First Society.

Effective recruiting also requires *personal contact*, and the most effective personal contact is face-to-face. To be a successful recruiter, you simply have to talk with your potential customers. They need to learn about and from you, while you need to learn about them. They expect and deserve a personal invitation from you to join the Freedom First Society — if you determine they are qualified for membership.

**The Bottom Line:** The means to defend freedom are certainly available. And defend we must, or soon we and our families will stand defenseless before a merciless, satanic enemy. The outcome will depend on our courage and determination in this protracted battle. It’s time for our side to rally those who love freedom to its spirited defense.

## Congress: Just Vote the Constitution!

We have repeatedly emphasized that a (*future*) “constitutionalist” House will need the leverage from true regular order — voting on the 12 appropriations bills independently — to impose its “power of the purse” and force a rollback of unconstitutional government incrementally.

The current, as we go to press, *partial* government shutdown shows that big-government *could* be trimmed piecemeal. A recent poll report (1-13-18) stated:

Only 18 percent in this poll, produced for ABC by Langer Research Associates, say they’ve personally been affected by the partial shutdown.

### Poll Reports in General

Of course, poll reports must always be read very carefully. They are often designed to convince readers that they are out of step with their fellow Americans and thereby to undermine our will to resist.

For example, the opening paragraph of a report by *The Hill* (1-9-19) stated:

Nearly 60 percent of GOP voters in a new poll say that the Congress divided between a Democratic

House and Republican Senate will do the same or better than the previous one, which had GOP majorities in both chambers.

But combining “same or better” into one statistic is misleading. In the next paragraphs, we find that only 22% of GOP voters expected the new “divided” Congress to do a better job, whereas 41% expected the new Congress to do a worse job. Even the remainder of the 60% who expected the divided Congress to perform about the same could well consist mostly of realists who saw Congress continuing to do a bad job.

### Compromise “Farm Bill” Scored

For the last Congress, we scored the final compromise vote in both the House and Senate on the 2018 “Farm Bill,” which includes the SNAP program (formerly “food stamps”). President Trump signed the authorization measure into law. (See, for example, House Roll Call 434, 12-12-18.)

Let’s build the informed electorate required to compel the House to embark on principled action!

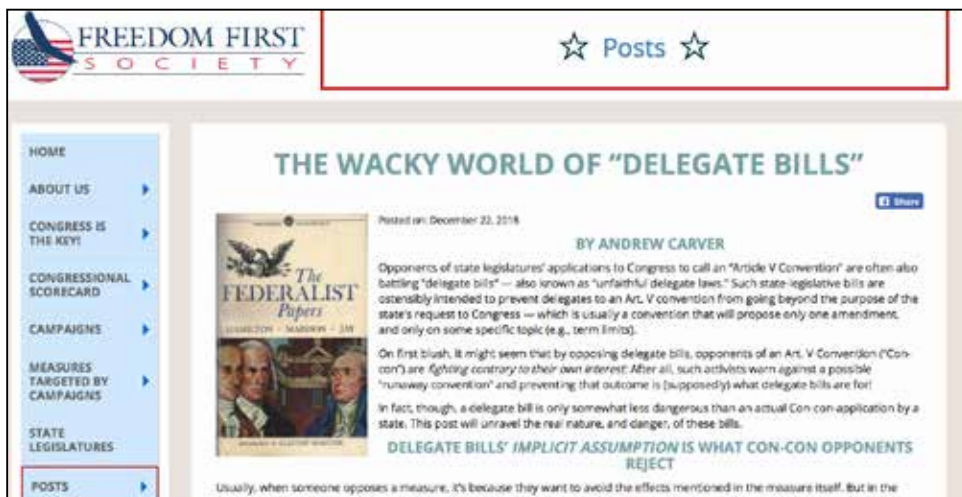
