**Freedom loses big-time:** President Trump's signing of the United States-Mexico-Canada Agreement (USMCA) on January 29th was a tremendous blow to our nation. Using trade promotion as the cover, the USMCA follows the "progressive regionalization" strategy of the Internationalist Conspiracy for building a world tyranny. That strategy trapped the nations of Europe in the EU and opened their borders to unrestrained migration. At a subsequent White House briefing (r), President Trump disingenuously touted his border wall, which would become useless once his USMCA evolves as intended and mandates open borders. The Council on Foreign Relations' (CFR) Robert Lighthizer (behind the President) negotiated the USMCA power grab, which strengthens unaccountable regional authority.

### The USMCA Attack on America

President Trump's enthusiastic support for the USMCA should set off alarm bells among the President's conservative supporters. For *the USMCA is not simply a trade agreement*, as touted by the President.

Indeed, as our recent post, "The USMCA Scam," shows, trade is the cover for a treacherous assault on our nation's independence, employing the deception used to trap the nations of Europe in the EU. Beneath its trade cover, the USMCA is a further step in the Internationalists' deception known as "progressive regionalization," a strategy to overcome resistance to world control by a ruthless, unaccountable elite.

As one of several subversive

consequences, the USMCA threatens to render President Trump's campaign to build a Southern border wall completely useless. Clearly, "open borders" is fundamental to the regionalism strategy, as exemplified by the EU.

A January 27th British Broadcasting Corporation (BBC) post, entitled "Brexit: All you need to know about the UK leaving the EU," should be a wake-up call for America:

### What is the European Union?

The EU is an economic *and political union* involving 28 European countries. It allows free trade, which means *goods can move between member countries without any checks or extra charges*. The EU also allows *free*

*movement of people, to live and work in whichever country they choose.*

The UK joined in 1973 (when it was known as the European Economic Community) and it will be the first member state to withdraw.

Note: The United Kingdom joined the EU when *the union was still posturing as a mere trade agreement* — the European Economic Community,

also known as the Common Market.

If the USMCA evolves per the Internationalist plan, with open borders for goods and people, Congress will have surrendered its constitutional authority to regulate commerce.

But opening up our Southern border to unrestricted migration is an even greater assault on our future as a free nation. Migrants who have known only socialism will inevitably bring with them the same support for socialistic government from which they are fleeing.

Although the UK's physical isolation from the European continent makes withdrawal in some ways more achievable, even now *Brexit isn't a finished reality*. The entanglement is immense. Again, from the BBC post:

## What happens after Brexit day?

After the UK formally leaves

the EU on 31 January 2020, there is still a lot to talk about and *months of negotiation will follow*.

While the UK has agreed to the terms of its EU departure, both sides still need to decide what their future relationship will look like. *This will be worked out during the transition period ...*, which begins immediately after Brexit day and is due to end on 31 December 2020.

During this 11-month period, *the UK will continue to follow all of the EU's rules and its trading relationship will remain the same*. [Emphasis added.]

Consider: In June 2016, after much public demand, the British government finally put the Brexit issue to a popular vote. The referendum was approved by a narrow margin. In the intervening three years, British Internationalists repeatedly sought to frustrate the popular vote. The BBC post answers "Why did Brexit take so long?":

Brexit was originally meant to happen on 29 March 2019, but the deadline was delayed twice after MPs rejected the deal negotiated by Mrs. [Theresa] May, the prime minister at the time.

Many Conservative MPs and the DUP (the government's then ally in Parliament) were unhappy with the backstop — arguing that *the UK could remain trapped in the arrangement for years with no way out*.

After MPs voted down the deal for a third time, Mrs. May resigned.

Mr. Johnson needed a Brexit extension of his own after MPs failed to get the revised deal passed into law. [Emphasis added.]

## The CFR Internationalist Hand

Conservatives should keep in mind that President Trump chose Robert Lighthizer, a member of the Internationalists' CFR, to negotiate the complex agreement. More than 200 members of his administration, many of whom had earlier worked on NAFTA, crafted the revised 2,082-page agreement.

After negotiating his first USMCA agreement, Lighthizer arranged further changes to bring liberals and Big Labor on board. Liberals insisted on further strengthening the ability of unaccountable regional institutions to enforce *Internationalist* rules. The resulting Internationalist power grab was then touted as bipartisan, in itself a red flag.

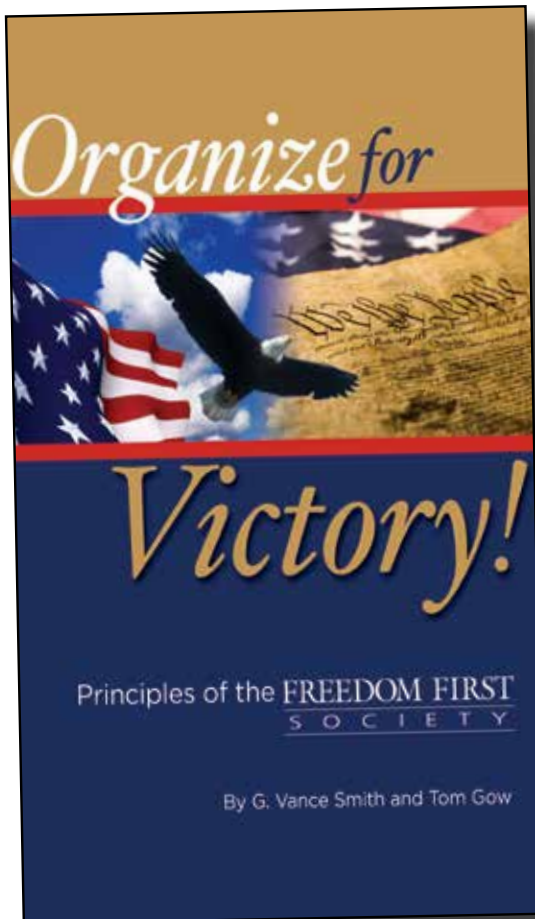
With respect to its cover deception — trade — the USMCA did open up export opportunities for certain products, such as dairy, but for manufactured products it also established rules of origin and *more regional government* to administer the rules.

And that should be the real concern. The USMCA supersized the NAFTA power grab, advancing the Internationalist objective of extinguishing our freedom. The Establishment's January 29th *Wall Street Journal* essentially admitted as much:

## Not-So-New Nafta

At its core, USMCA is an amended, rebranded version of the North American Free Trade Agreement, which took effect in 1994, along with *some newer provisions that the Obama administration had negotiated in a Pacific trade pact* that Mr. Trump exited. Both USMCA and Nafta *essentially guarantee* duty-free trade and *economic integration in North America*. [Emphasis added.]

## Great American Swindle, Part II

The Establishment media has long focused public attention on the presidential contest, as though we elect a King every four years to run things and that electing a president is the primary decision Americans make to control their government. It's a clever but sinister ruse to get responsible Americans to invest their energy and money in a race controlled by the Conspiracy, a race where, for decades, freedom loses regardless of who wins.

When we point out the flaws in President Trump's record, we're not suggesting that members look for a better candidate in 2020. We're saying: Forget about the presidential election (which we aren't strong enough to influence anyway), and focus on building Freedom First Society.

Why that focus? Recognize first the tremendous gains the Conspiracy has been making while President Trump is in office, particularly since most of his supporters have relaxed their concern. The USMCA is one example. We could also point to the enforcement of political correctness throughout federally supported Leftist education, polluting the minds of generations of our youth.

And realize that there is no movement in Washington to roll back conspiratorial gains, such as the federal usurpations of President Johnson's Great Society. Indeed, the pressure for such a movement must originate outside government.

Meanwhile, the Conspiracy promises even more successful assaults. President Trump has supported state "red flag" laws. And federal plans to profile citizens continue, which would lead to oppression of dissent through authoritarian incarceration. As we emphasize below, ignoring this centuries-old Conspiracy, or trivializing it as an anti-Trump Deep State, won't stop it. Again, the proper

leadership must come from outside government.

And don't waste your efforts right now trying to elect a good congressman. First things first. We *first* need to *change the climate* in selected congressional districts, and that requires growth in Freedom First Society's influence. Without an improved climate, sending a good guy to Congress will almost always be a disappointment, when he is co-opted by the Establishment forces that currently control Congress. The recent overwhelming vote in Congress to support the USMCA confirms that assessment. The vote reflects a lack of informed voters to overcome Insider clout. As experience shows, reason alone rarely moves congressmen. *They respond to clout.*

Since the CFR opened an office in Washington, DC, in 1990, the Conspiracy has steadily strengthened its grip on Congress, even while the public has been dumbed down to undermine effective resistance. Moreover, the CFR has strengthened its ability to control state politics and the promotion of serious candidates for Congress.

### Beware of Corrupted Sources

The first job of conspiracy

is to convince the world that conspiracy does not exist. — Dr. James P. Lucier, former minority staff director of the Senate Foreign Relations Committee, 1967.

As we discussed in Chapter 1 of *Organize for Victory!*, Robert Welch's response was: "And our first job is to show that it does."

The present-day Conspiracy, through its control of the media, has certainly done a thorough job of ridiculing any suggestion of conspiracy as only an unprovable theory — a product of uneducated minds looking for a simple explanation for complex events.

To drive home the point, the Conspiracy has highlighted the wild and easily discredited claims of convenient straw men. Friends of the Conspiracy likely funded some of these straw men. The important reality, however, is that you can't defeat this Conspiracy by ignoring it.

Almost by definition, single-issue groups aren't providing the necessary leadership. It's like the tree in our brochure (see graphic, below). While single-issue groups may provide useful research to those working to expose the Conspiracy, they also serve the Conspiracy by misleading potential opponents into fighting a single branch.





And we aren't even speaking of organizations such as Fox News, which have clearly been created for the purpose of neutralizing, even co-opting, conservative resistance.

Realize that most single-issue groups pull away from any discussion of Conspiracy or from admitting the big picture. Even if their leaders recognize Conspiracy, they may be constrained by sponsors who have bought the line that you don't dare talk Conspiracy lest you be regarded as ridiculous.

### Grow to Win!

We see only one possible remedy to avert America's demise. There must be a rise in organized leadership to help Americans see through the Conspiracy's many deceptions.

Here is one deception that affects many conservatives: "We should be satisfied to elect Republicans, because they are better than blatantly socialist Democrats."

The Establishment media fuels that common reaction by highlighting the radical proposals of Democrats and their growing support. For example, the House is considering a Democratic proposal to extend the deadline for states to ratify the subversive Equal Rights Amendment (ERA), as well as a bill, H.R. 51, to make Washington, DC the 51st state. H.R. 51 has been approved by a House committee, and House Majority Leader Steny Hoyer plans to bring it to a vote before the summer recess.

But focusing attention on the obvious wolves only to accept the wolves in sheep's clothing guarantees our defeat. The Establishment's Fox News, designed to appeal to conservatives, fuels this reaction. Indeed, radical Democratic proposals camouflage the subversive work that the GOP initiates (such as the USMCA) and that the GOP continues (such as big unconstitutional government).
